Report of the School Business Administrator:

Informational: The next meeting is Thursday, May 5, 2022 at 6:30 pm.

Budget – New Budget worksheets are provided to you at the table; When I reviewed everything before submitting the budget to the county, I found some errors in the appropriation lines that we looked at last month. The bottom line remains the same as what was approved, 0% tax increase. The total operating budget reflects 18,923 less in spending over the current year and the overall budget including the special revenues is \$34,019 less than the current year. The capital project is not included in these numbers.

Lunch Program — There is bill in the legislature commonly known as the "Working Class Families' Anti-Hunger Act" which would provide free meals to middle class families. NJSBA supports this bill. This is more evidence that it is prudent to join the national school lunch program for the 22/23 school year. We would like to discuss a shared service contract with Clinton Public in Executive Session concerning meal purchasing.

Pay Schools – We did a demo with Pay Schools to learn more about their food service platform and ability to accept payment for meals. Their options include pre-pay ordering for meals, point of service sales, as well as the ability to accept payments for other programs such as Pre-school tuition, student field trip fees, student activity money, etc. We are currently using a service through the bank to accept credit card payments for preschool, and the fees we pay for that would equal the cost of Pay Schools. There will be a one time set up fee, however, the actual cost of using their platform would be budget neutral based on what we are currently paying.

District's Policy 0167 - Public Participation in Board Meetings. The Board of Education recognizes the value of public comment on educational issues and the importance of allowing members of the public to express themselves on school matters of community interest. In order to permit the fair and orderly expression of such comment, the Board shall provide for two periods of public comments at every regularly scheduled meeting of the Board. Public participation shall be governed by the following rules:

- 1. A participant must be recognized by the presiding officer and must preface comments by an announcement of his or her name, place of residence, and group affiliation, if appropriate.
- 2. Each statement made by a participant shall be limited to a reasonable time as determined by the presiding officer.
- 3. No participant may speak more than once on the same topic until all others who wish to speak on that topic have been heard.
- 4. All statements shall be directed to the presiding officer; no participant may address or question Board members individually.
- 5. The presiding officer may
 - (a) Interrupt, warn, or terminate a participant's statement when the statement is too lengthy, personally directed, abusive, obscene, or irrelevant to the district;
 - (b) Request any individual to leave the meeting when that person does not observe reasonable decorum;
 - (c) Request the assistance of law enforcement officers in the removal of a disorderly person when that person's conduct interferes with the orderly progress of the meeting;
 - (d) Call for a recess or an adjournment to another time when the lack of public decorum so interferes with the orderly conduct of the meeting as to warrant such action; and waive these rules when necessary for the protection of privacy or the efficient administration of the Board's business.
